ALTERATION OF THE CONSTITUTION OF CANTERBURY WOMEN'S LEGAL ASSOCIATION INCORPORATED

At the Annual General Meeting of the Association held on 7 May 2015 the following resolution was passed:

- 1. That the rules of the Association be amended by the replacement of the numeral (7) and the word Seven with the addition of the numeral (10) and the word Ten in clause 15.
- 1.1. The effect of this amendment is that clause 15(a) will now read as follows:

"The conduct of the affairs of the Association shall be vested in a Committee. The Committee shall consist of a Convenor, a Secretary, and a Treasurer and up to (10) Ten other members".

2. This alteration of the Rules was passed at the Annual General Meeting on 7 May 2015.
